AN ORDINANCE AMENDING PARTS OF ZUMBROTA CITY CODE CHAPTER 72: PARKING REGULATIONS SPECIFICALLY RELATING TO LIMITED TIME PARKING

The City Council of Zumbrota, Minnesota ordains:

Section 72.03 of the Zumbrota City Code, Limited Time Parking, is hereby repealed in its entirety and replaced with the following:

§ 72.03 LIMITED TIME PARKING.

- (A) Authority. The City Council may, by resolution, designate certain areas where the right to park is limited during hours specified. The City Public Works Director shall mark by appropriate signs each zone so designated. During the hours specified on the sign, no person shall park a vehicle in any limited parking zone for a longer period than specified.
- (B) Time limitation; parking permit. No person shall leave standing any legally parked motor vehicle or utility trailer upon any street or public parking lot for a continuous period in excess of 72 Hours. Due to extenuating circumstances, an extended parking permit may be issued for a period of an additional 72 Hours in designated parking lots only by the City Administrator for a motor vehicle or trailer. Written notice will be posted that the vehicle needs to be moved, the vehicle shall be moved within 24 hours of the notice being issued.
- (C) Removal of indicator of parking time. It shall be unlawful for any person to obliterate, erase, or remove any mark or sign placed on a vehicle by a police officer for the purpose of measuring the length of time that vehicle has parked.
- (D) Enforcement. For purposes of enforcement of divisions (A) through (C), any vehicle not reasonably moved less than 100 feet shall be deemed to have remained stationary. Nothing in this section shall be construed to limit the application of § 72.06 which provides penalties for interference with snow removal operations.
 - (E) Restrictions in downtown parking zone.
 - (1) No person shall park a motor vehicle for longer than two continuous hours on the following streets: Main Street from the intersection of First Street and Fifth Street.
 - (2) In the event of extenuating circumstances, any person may apply with the city for a parking permit authorizing an extended parking period, which permit, upon good and reasonable cause shown by the applicant, may be granted by the City-Council Staff.
- (3) Appropriate signage shall be placed within the limited parking zone defined herein.

This amendment to ordinance becomes effective on the date of its publication, or upon the publication of a summary of the ordinance as provided by Minn. Stat. §412.191, subd. 4, as it may be amended from time to time, which meets the requirements of Minn. Stat. § 331A.01, subd. 10, as it may be amended from time to time.
